Booking Policies, Procedures, Terms & Conditions

It is IMPORTANT to please READ CAREFULLY and review these TERMS AND CONDITIONS BEFORE REGISTERING for one of our programs. This agreement is between you and Safety First Driving Academy, LLC. It refers to the services provided by Safety First Driving Academy. As described on our website, WWW.SAFETYFIRSTFL.COM. By registering for any of our programs you acknowledge that you have read and agree to all the TERMS AND CONDITIONS. You also acknowledge that you are the parent or legal guardian of the student or that you are at least 18 years of age.

-Parental Consent-

The parent or legal guardian of the student hereby agrees to allow their daughter or son to take part in a one-on-one driving lesson with a State Certified Safety First Driving Academy driving instructor and to take part in all the courses that correspond with the programs in which the student is enrolled in.

-Registration & Paperwork-

Registration is available for our programs online VIA our website, or over the phone. Upon submitting student information and payment, online through our website or VIA phone, this contract must be filled out, signed, and emailed back to Registration@safetyfirstfl.com. All documents must be filled out with the full legal name of the student matching Learner's Permit. Once submitted, the registration will be completed. Once the contract is received a Safety First Driving Academy scheduler will reach out to the student (and/or parent/legal guardian, whichever applicable) and ask for availability and discuss a schedule VIA email or phone. Prior to the first lesson, the instructor is required to make a photocopy of the Learner's permit for our records.

-Driver's License & Learner's Permit-

A student must hold a valid, original copy of their Leaner's Permit or their Driver's License on their person, a photocopy is not accepted, prior to every lesson or the lesson will be forfeited.

-Payments & Payment Plans & Outstanding Fee's-

Payment plans are available for select programs, please contact the office directly for terms and conditions prior to registration. Payment plans are not accepted online and must be requested VIA phone at time of registration. We take debit/credit, VISA, MasterCard, AMEX, Discover. Checks and/or Money orders will be accepted by mail prior to any lessons being scheduled and until the check is cleared. Cash is accepted on a case-by-case basis. Returned check fees will be charged at the max allowable rate. All outstanding fees and balances must be paid prior to the start of the next lesson.

-Refund/Cancellation Policy-

Safety First Driving Academy, LLC Is in the business of providing service, namely the service of providing training and knowledge. Knowledge is a non-material commodity that cannot be returned or exchanged; therefore, we cannot refund money and services. Although, in the event that you are dissatisfied with our service, you can fill out our refund request form and we will review your request on a case-by-case basis, or we will allow

the remainder of your payment, if any, to be transferred to another student as a credit towards their instruction. Last minute cancellations on behalf of the student are subject to lesson forfeiture. Instructors will make any reasonable accommodations for last minute scheduling changes when possible. Due to unforeseen circumstances such as traffic or construction, the instructor may arrive late for the driving lesson. Keep in mind if arriving late the instructor will still conduct the driving lesson at the appropriate length determined by the instructor. Any lesson shortened from the scheduled time will be made up in the form of an extended lesson or in additional lessons.

-Rescheduling Lessons, No Show Appointments, & Scheduling Policy-

Safety First Driving Academy, LLC In its sole discretion, reserves the right to reschedule a student's appointment based on instructor availability for any of our services with no fees charged to the student. If the student needs to reschedule a lesson, he/she needs to give at least 48 hours' notice to avoid a \$40 reschedule fee. If the student does not contact the scheduler or their instructor, they will be charged the \$40 fee. The instructor may have an illness or sudden emergency and therefore, may have to reschedule a lesson the day of. Safety First Driving Academy will promptly notify the student as soon as possible if any of these circumstances should arise, and when agreed, the student will not be charged to reschedule the lesson. While we understand that things happen, our instructors build their days around prescheduled lessons and commute times. Instructors will wait 15 minutes, no more than 30 minutes after the scheduled lesson time and they will attempt to contact VIA phone and text before being considered a No Show. If there is a No-Show appointment, that lesson will be forfeited. It's the student's responsibility to ensure Safety First Driving Academy can meet their scheduling needs prior to completing their registration. Safety First Driving Academy will make every attempt to accommodate every student's needs in scheduling. If there is a deadline for a student, it's expected that the student, parent, or legal guardian contact Safety First Driving Academy. In advance to registering to confirm the deadline. We will make accommodation for students that have immediate needs in going away to College, the Military, Residency changes, as well as sports and activity schedules, etc. Once finished with registration, Safety First Driving Academy. Will provide a start date. Upon being assigned to an instructor, students can expect communication VIA phone, text, or email. Lessons usually consist of 120 minutes (about 2 hours) in length. Please consult with your instructor if you have specific lesson duration requests.

-Changing a Pickup/Drop Off Location, Geographical Restrictions-

Students may change the pickup and drop off location, with parental consent, for a behind the wheel lesson, but it must be within Safety First Driving Academy's geographical limitations and must be approved 24 hours in advance by the instructor. Safety First Driving Academy within its sole discretion has the right to deny any new pick up/drop off location. Last-minute changes may result in a loss of lesson time to accommodate. It is the student/parent/legal guardians' responsibility to ensure each program they sign up for is within Safety First Driving Academy serviceable radius. If a student wishes to be picked up outside Safety First Driving Academy's serviceable radius, then he/she must consult prior to registration. Additional rates may be incurred for additional travel time, and that charge will be determined on a case-by-case basis.

-Safety Behind the Wheel-

We reserve the right to stop a lesson at any time due to the student being reckless and/or for careless driving or unsafe conditions. Driving Instructors may take control of the car at any point during a lesson if they feel that the driver is unable to complete the lesson safely. If a lesson must be discontinued for any reason, the remainder of the lesson is subject to forfeiter, however we will do our best to accommodate the lesson time in the form of extending it onto a future lesson or doing an additional lesson. Students will wear appropriate clothing and footwear for lessons. Beach wear and/or flip flops/crocs are not suitable.

-Vehicles / Use of Our Vehicle-

All Safety First Driving Academy vehicles will be kept up to date with current registration, regular vehicle maintenance and servicing, tire pressure and all necessary repairs. All necessary safety precautions will be taken before the student gets in a Safety First Driving Academy vehicle for his/her lessons. Should anything happen to

any Safety First Driving Academy vehicle, which effects its safety or mechanical operation immediately prior to and/or during a lesson, Safety First Driving Academy will, at its sole discretion, either reschedule a pro-rated lesson or schedule another lesson at no cost to the student on a case-by-case basis.
